**PROGRAM:** Timbuktu Academy's Academic Empowerment Boot Camp for Middle School and High School Students

**Orientation:** Mandatory parent **and** student orientation will be held Sunday, June 4, 2017, at 3:00 p.m. in Room 142 of William James Hall

**Duration:** This is a six-week summer program. It starts Monday, June 5, 2017, and ends Friday, July 14, 2017.

**Program Time:** 8:00 a.m. - 5:00 p.m.

**Description:** The Timbuktu Academy is an academic empowerment program designed to enhance students' critical thinking skills, mathematics skills, English skills, and reading comprehension skills. The academic enrichment courses are designed to enhance students' skills and to prepare them for future high school or college studies. The enrollment for the Timbuktu Academy's commuter program at SUBR is one hundred (100) students.

**Criteria:** Participants must be entering the 8th, 9th, 10th, 11th or 12th grade. Judgment and character are among the criteria for participating. Students must have an acceptable school disciplinary record.

**Cost:** The **non-refundable** enrollment fee is \$750. Lunch will be provided by the Food Lunch Program at McKinley High School (M-Th). On Fridays, the students will pack a bag lunch. We do not offer scholarships; we do not offer a reduction in the enrollment fee for multiple siblings. We do not adjust the enrollment fee for absences. We do not give refunds if the student is dismissed for reasons such as inappropriate behavior, poor health, sickness, vacation, etc.

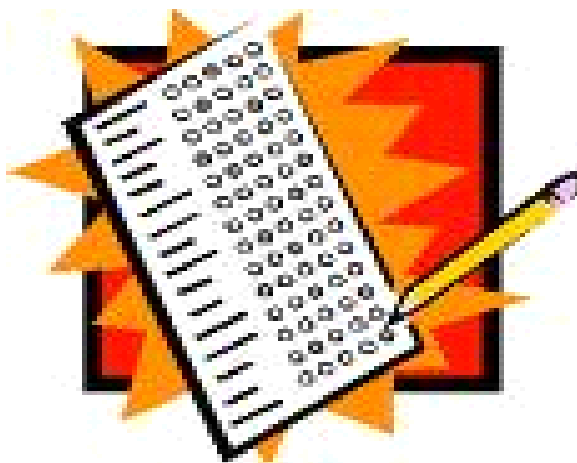

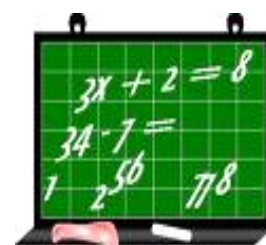

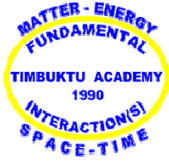
